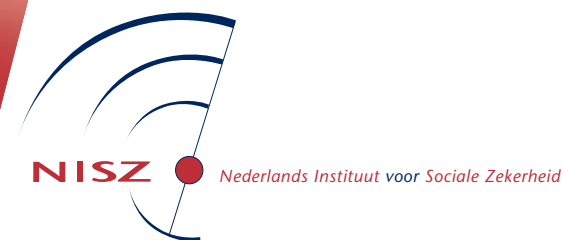

Topic

From the origin of statutory social security, schemes are based on the idea that everyone follows a standard career path. The starting-point is that everybody is supposed to work between the completion of education up to the age of 65 at which age everybody retires. Nowadays, there are more and more differences in life cycles and it is important to discuss whether social security can take better account of these variations.

The question is whether the present social security schemes present sufficient protection in case of unemployment, disability, old age, early retirement, etcetera. And if they do not, is better protection possible by offering more individual choices in order to link social security better to life cycle variations?

This question leads to an investigation of the possibilities of introducing more choice opportunities within the legal systems in view of life cycle variations, for instance by allowing choices between claiming benefit or saving for the future, by allowing the choice between being insured for survivors' insurance or getting a higher old age insurance, by including savings' options in the statutory system.

Of course, such alternatives easily raise questions on the sustainability of the system, the solidarity between the various insured groups and the relation of the statutory system with private social security.

The topic will be approached - following the multi-disciplinary character of EISS Conferences - from various perspectives, including legal, sociological, and economic disciplines according to the themes mentioned in the programme.
