## Tackling new forms of work in social security

Labour markets are changing across Europe; this is partially due to growing digitalization and informatisation in our current industries, but also partially caused by the economic globalisation and various market pressures. At the same time flexible labour forms, such as casual work, free-lance work, platform work, on-demand work, part-time work, self-employed work (bogus or genuine) are increasingly in demand by employers. Persons working on the basis of these alternative work forms can be swiftly hired and fired by employers and can be more easily integrated in modern production processes. Hence, due to their flexible character they become an important element in entrepreneurial strategies to save production costs and help enterprises to face the growing competition in the globalised economy. Moreover, the recent Covid-19 crisis amplified the use of such work, especially in the form of telework and platform work.

However, apart from labour law challenges, flexible work forms, create also a number of challenges for the organization and financing of social security schemes. The latter schemes, at least when addressing professional groups, have often been designed with the standard worker in mind, i.e. the full-time employee working in a subordinated relationship on the basis of an open ended labour contract. New forms of work, deviate from standard work in one or more of these elements: work is contracted part-time and/or definite in duration; the income of the non-standard worker is not coming from one employer or client, yet can be generated across a variety of commissioned (short-term) work assignments. The workers' income may show over time an irregular pattern, the size of which is dependent upon the number of work assignments and negotiated tariffs. If many providers are available on the market, the worker may face fierce competition and structural low income returns. Sometimes work itself is part of the provided service in case it is made available by the employer to a third party (agency work), making it unclear in the end which party in the end can be considered as the real employer.

New forms of work are growing in size, amounting now to approximately 40% of the workforce in the EU. Social security systems consequently need to be reshaped in order to keep the new work forms on board. With this conference we have the ambition to highlight the challenges that flexible and new forms of work generate for traditional social security systems. The conference aims at giving first an overview of the flexible work forms that emerged during the last couple of years and the changing labour markets that are at the origin of these modifications. The overview is followed by an in-depth analysis on how these evolutions challenge current social security systems in practice and how countries try to incorporate concretely non-standard work and self-employment in their social protection schemes. In order to do so we focus upon a selected number of challenges which systematically unfold in the ongoing debates: the financing of social security and the concrete (difficult) organization of social security schemes such as pensions, unemployment and work incapacity schemes for non-standard workers and self-employed. Finally, attention is given on how the European Union is addressing the growing number of non-standard work and self-employment in its regulatory framework. Hence the recent EU Recommendation (2019) setting standards in the field of access to social security and the EU Regulation 883/2004 (coordination of social security in the field of free movement) will be looked upon more closely.
